General framework

Mariëtte van den Hoven provided an overview of the management structure and the project design as stipulated in the Grant Agreement. Special attention was given to:

- Appointing innovation officer & gender/equal opportunity officer
- External Advisory Board (EAB)
- Quality Control Procedure

Overview and discussion of Work Packages

Each Work Package leader presented their deliverables, tasks and milestone.

• WP 1 (Data Management Plan): a Data Management Plan (DMP) is mandatory and must be uploaded in the Portal in month 6 at the latest. Processes that handle personal data must be





designed and built with consideration of the principles of The General Data Protection Regulation of the EU (GDPR) and provide safeguards to protect data (for example, using pseudonymization or full anonymization where appropriate), and use the highest-possible privacy settings by default, so that the data is not available publicly without explicit, informed consent, and cannot be used to identify a subject without additional information stored separately;

- WP 2 (Survey tool): Students don't see the problems as we see them. Is this a lack of ethics or of understanding? What are the real issues they face? Are there different traditions or ways of doing things? First qualitative research to find out what the issues are, then make the questionnaire. Each partner has been allocated 1 p/m for this WP:
 - o Gender & Research Integrity: Carline Klijnman gave a review of the literature;
 - o Online courses: presented by Elevate;
- WP 3 (Inventory and Checklist): UZH and UU discuss how to best fulfill the tasks in this WP
- WP 4 (Developing and designing novel RCR-teaching): All consortium members are involved. The project plan does not state who is responsible for which task. We need to decide timely on how to divide roles and responsibilities. (Also important for WP 5). Note that WP starts before deliverables of WP 2 and WP 3 are due. Autumn months of 2019 are crucial for the overlaps. Identify what are the needs of students and teachers. WP2 and WP3 connects here with WP4. SPOC in 3rd year: structure the duration. Which target group ate you interested in to use. Be precise on what is feasible in the end. For each task someone is responsible and assign the task;
- WP 5 (Train the Teacher): will be discussed further during next annual meeting, as it doesn't start for 1,5 years:
 - o imCode gave a presentation where defendind that adaptation of cinema methodologies can be used to improve teaching techniques - story in their own language;
- WP 6 (Nudging): presented by UNIGE;
- WP 7 (Communication and dissemination): proposals for the project visual identity was presented, the *url* for website was defined www.h2020integrity.eu and it aws discussed which tool for communication to use within the project.
